Sick Policy Please keep your child home if they have experienced any of the following symptoms within 24 hours prior to attending any MOMS Club® function. - Diarrhea - Earache - Fever of 100 or higher (children should stay home until their body temperature has remained normal for 24 hours) - Green or yellow nasal discharge - Heavy cough/croup - Pinkish appearance of eye, especially with discharge - Sore throat/swollen glands - Unexplained rash/Poison Oak - Vomiting or Nausea - Exhibit any symptoms of childhood communicable diseases such as, but not limited to, chicken pox, measles, mumps, lice, 5th disease or hand-foot and mouth disease or whooping cough. Please contact the President if your child has contracted a communicable disease.

Thank you for helping to keep our infants, children and mothers safe. Children's Code of Conduct MOMS Club® activities are meant to be enjoyable and safe events for both parents and children. The MOMS Club® respects parenting differences but expects that all children behave appropriately at MOMS Club® activities. Unacceptable behaviors include but are not limited to:

**· Hitting · Scratching · Kicking · Biting · Spitting · Slapping · Hitting with objects · Hair pulling · Destroying or being disrespectful of property**

· Inappropriate touch · overly aggressive behavior In the unfortunate event that these behaviors occur during MOMS Club® activities, then the child's mother should temporarily remove the child until the behavior has been corrected. If this does not occur, a member may be asked to temporarily remove their child until the behavior has been corrected. This may be done at the discretion of the Executive Board. Resuming activities will also be at the discretion of the Executive Board. This Policy is in place to ensure the enjoyment and safety of club members and their children. Mom's Code of Conduct Policy MOMS Club® is here to support mothers who choose to stay at home with their children. We support all mothers and recognize that there are many different parenting styles and personalities in our Club. To ensure a safe, supportive atmosphere, we ask the following of all members: \*You are responsible for your children at all MOMS Club® functions. If you cannot supervise them all, please talk to other members ahead of the event to see if they can lend a hand, or bring a relative or other helper (babysitter) to assist you. \*When disciplining your children, please speak in a reasonable voice or remove the children from the area. Loud voices and yelling are upsetting to other children and are disruptive. Please remove your children from the area for time-outs. \*Do not discipline another mom's children without their permission. In the event that your child is in conflict with another child, please separate them and take the other child to his/her mother. \*As a support group, there will be many conversations with and about members. To be supportive, no negative gossip or demeaning comments are allowed. Please also respect the privacy of members who do not have an outgoing nature.



\*You are responsible for reading and following the by-laws of this club at MOMS Club® activities, including the general by-laws, the Children's Behavior Policy and this policy.

\*To ensure the comfort of moms from all economic and cultural backgrounds, we ask that all members follow the above guidelines. In the unfortunate event that these guidelines are not followed, the Executive Board will discuss the issue with the member(s) involved.
